

ORDINANCE NO 19-01.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF IRETON, IOWA, BY ADDING A NEW SECTION ADDITIONAL REGULATIONS, CITY REGISTRATION

BE IT ENACTED by the City Council of the City of Ireton, Iowa:

SECTION 1. NEW SECTION. The Code of Ordinances of the City of Ireton, Iowa, is amended by adding a new Section 75.08, entitled ADDITIONAL REGULATIONS which is hereby adopted to read as follows:

75.08 ADDITIONAL REGULATIONS. The following additional regulations shall be observed by operators of snowmobiles and ATV/UTV in addition to complying with all other applicable Federal, State and City laws, ordinances and regulations while operating on “permitted travel routes” or elsewhere within the City limits:

1. The operator shall obey all traffic laws applicable to automobiles.
2. The operator shall be at least 16 years of age and have a valid motor vehicle operator’s license in his or her possession.
3. The operator shall have in his or her possession proof of proper registration and proof of financial responsibility.
4. The snowmobile or ATV/UTV shall be equipped with a headlight and taillight which are in good working order and which shall remain lighted at all times.
5. All snowmobiles and ATV/UTV operated within the City limits shall be equipped with a muffler in good working order and in constant operation. No person shall operate a snowmobile or ATV within the City limits, which is equipped with a muffler cut-out, bypass or similar device.
6. Snowmobiles and ATV/UTV shall not be operated in any part of the City park system as stated in 75.04(5 & 6) and 75.05(4), nor shall they be operated on any private property without the express permission of the property owner.
7. ATV/UTV shall not be operated between the hours of 10:00 p.m. and 7:00 a.m. Snowmobile hours are designated in 75.04(2).
8. No snowmobile or ATV/UTV shall be operated on any City-owned and operated property within the City limits except those streets and alleys designated in Section 75.04(1) and 75.05(1) as “permitted travel routes,” except any City-owned property leased to a private party when the private party has granted express permission to the operator.

SECTION 2. NEW SECTION. The Code of Ordinances of the City of Ireton, Iowa, is amended by adding a new Section 75.09, entitled City Registration which is hereby adopted to read as follows:

75.09 CITY REGISTRATION. No person shall operate an ATV/UTV on any public street or alley unless said ATV/UTV is registered with the City. ATV/UTV owners may register an ATV/UTV with the City Clerk using forms provided by the City. The Clerk shall not register an ATV/UTV until the following have occurred:

1. The owner has provided evidence that the ATV/UTV is registered as required by Iowa law, and that such registration is current. The owner/operator shall maintain such registration.
2. The owner has provided proof of current financial responsibility in accordance with Chapter 321.20B of the *Code of Iowa*. The owner shall maintain such financial responsibility.
3. All registrations issued shall uniquely identify the name and address of the owner/operator.
4. Registration Sticker. A City registration sticker shall be displayed visibly and prominently.

Registrations shall be effective from January 1 through December 31. Registrations may be renewed upon application for renewal with the Clerk.

SECTION 3. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 4. SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 5. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
